Call to Order: Livingston

Presentations:

- **a. DHEC Recycling Award Presentation:** Paul Alcantar was presented with the award, and a brief overview was given of America Recycles Day.
- b. Richland County Recreation Commission \$50,000,000 Bond Status: Bob Redfern, Interim Executive Director, and Frannie Heizer, Bond Counsel, gave a brief update on the bond. There are seven properties to be purchased. Tracts on Garners Ferry Road, Marley Drive, and Parklane Road have been purchased. One tract is under contract. The RFQ has gone out for construction management, and Architecture and Engineering services. The financing plan is on track. The first long term bond issue should occur around August 2009.

- a. Employee Grievance (3): Council voted to uphold the Administrator's recommendations. ACTION: ADMINISTRATION, HUMAN RESOURCES
- b. Stimulus Update: Mr. Pope provided council with an update on the county's effort to secure federal funding from the American Recovery and Reinvestment Act of 2009. The Stimulus Ad Hoc Committee (Livingston, Jeter, Dickerson, Jackson, and Pearce) has established a regular meeting schedule. During the last meeting on Thursday, April 16th, staff provided the committee with an update of funds received to date, an overview of pending formula funds, a report from the Sheriff and Community Development Departments, and a discussion of potential grant programs of interest to the county. Mr. Pope stated that staff would forward an update electronically to all members of council. ACTION: ADMINISTRATION

d. NACO Prescription Card Update:

- 1. The NACO card has been used on 28,054 Prescriptions since the program began in July 2006.
- 2. County residents have saved a total of \$310,013.46 since the program began.
- 3. The average savings per prescription is 24%.
- 4. The card has been used by 7,789 citizens since the program began.
- 5. Our program is the third largest in the state based on the number of monthly users.

Section 26-180. Signs.

The following language would be inserted as the section immediately following Section 26-180(o) of the Richland County ordinances.

(p) Changeable copy signs. Legal nonconforming off-premise signs in Commercial, Manufacturing and Industrial Districts may be replaced in whole or in part by surface area displaying changeable static images controlled by electronic communications (hereinafter digital) as provided by this section.

(1) A permit to replace legal nonconforming off-premise sign display surface area with digital surface area shall first be obtained as provided in Sec. 26-180 (a) (2).

(2) A digital sign as provided by this section shall not be considered flashing or blinking for the purposes of this section when the copy shall remain fixed for a period of at least 6 seconds between changes. The interval between copy changes shall be no longer than 1 second.

(3) Digital shall not include animated, continuous, moving, rolling, or scrolling messages or video displays.

(4) Digital shall have an automatic dimmer and a photo cell sensor to adjust the illumination intensity or brilliance of the sign so that it shall not cause glare or impair the vision of motorists, and shall not interfere with any driver's operation of a motor vehicle. In addition, digital shall not exceed a maximum illumination of 7,500 nits (candelas per square meter) during daylight hours and a maximum illumination of 500 nits between dusk to dawn as measured from the sign's face at maximum brightness. Digital shall not be permitted within 300 feet of any residential district towards which the sign is oriented.

(5) This permissibility does not include the replacement of, or some other substantial alteration to, the sign support structure, except that existing metal sign support structures may be replaced with new metal sign support structures pursuant to a permit to erect digital.

(6) A digital sign may be reestablished after damage or destruction by an act of God, where the estimated expense of reconstruction does not exceed fifty percent (50%) of the appraised replacement cost of the sign structure, exclusive of the value of any digital display device.

(7) There shall be 1000' spacing of digital on same side of the road; there shall also be 1000' spacing of digital on opposite side of the road for digital if facing the same direction.

(8) Digital shall be allowed only on 'arterial' streets as defined in Richland County ordinances.
