#### **CALL TO ORDER**

Ms. Dixon called the meeting to order at approximately 3:32 PM

An Ordinance Amending the Richland County Code of Ordinances; Chapter 26, Land Development; Article VII, General Development, Site and Performance Standards; Section 26-173, Off-Street Parking Standards; Subsection (F), Parking of Recreational Vehicles, Boats, and Travel Trailers; so as to add utility trailers

Mr. Malinowski moved to eliminate the above-referenced ordinance due to this being a private matter that should be dealt with by individual communities or homeowners groups.

Ms. Dixon inquired of legal, how the elimination of the ordinance will affect the communities that do not have an active HOA or Management company.

Ms. McLean stated the County will have no right to go in and help them since the County will no longer be regulating off-street parking standards. If the communities do not have deed restrictions or covenants as a part of their subdivision then they can park wherever they want unless it is in violation of another County ordinance.

Ms. McLean stated if there is a safety issue then the resident would need to contact the Sheriff's Department and let them know there is a vehicle blocking the driveway, right-of-way, etc.

Presently the County's Code Enforcement officers enforce this matter.

Ms. McLean inquired at to what kinds of complaints are received regarding this ordinance.

Mr. Price stated the majority of the complaints deal with not wanting the trailers, boats, etc. visible in the front yards.

Ms. Linder stated she needs to research the amendment to Section 17-10(a)(4) to insure consistency with deletion of the above-referenced ordinance.

Mr. Malinowski moved, seconded by Ms. Dixon, to defer this item. The vote in favor was unanimous.

In suburbs or subdivision the maximum height for grass should be 12 inches similar to the City of Columbia, Richland County has one of the tallest height in the Midlands of 24 inches [JACKSON] – Mr. Hammett stated this already takes a lot of code enforcement's time. The owners are usually out-of-state and Public Works ends up cutting the grass.

Ms. McLean stated a lien cannot be placed on the property for these services and ultimately the County foots the bill for mowing the grass.

Mr. Malinowski moved, seconded by Ms. Dixon, to defer this item. The vote in favor was unanimous.
