**b. Contract Award: Water Quality and Water Quantity Model Development**

**c. Contract Award: Resurfacing 2003 Project**

The Committee is requested to approve the award of a construction contract to Sloan Construction Company, Inc. in the amount of \$1,279,400.00 for the resurfacing of approximately eleven (11) miles of roads throughout Richland County.
