Section 5: New Business Opened During 2022 (first license with Richland County)

Renewal information for new businesses that opened last year was sent by email.

To help businesses renew a Richland County license for the first year, the Business Service Center will email these businesses information beginning in January. That email will request certain business information to be provided to our office by REPLY email. Our staff will then calculate the business license tax, email the amount due along with instructions to pay the fee online. Businesses may also print Page 1 of the email and mail that page with the business license payment to our office.
