Richland County has subgranted with two non-profits to provide Homeless Prevention and Rapid Re-Housing assistance to eligible households. The expected outcomes are to stabilize at risk households and to quickly house those that are homeless by assisting at least 15 Households per quarter.</p>

<p>Quarterly Activities/ Project Description</p> <p>Homeless Prevention and Rapid Re-Housing Program (HPRP)</p> <p>During this reporting period the grantee and subrecipients continued to view the HUD (Housing and Urban Development) webinars. Additional guidance, thru HUD technical assistance and attending the HMIS (Homeless Management Information System) /HEARTH (Homeless Emergency And Rapid Transition to Housing) Conference Training has clarified upcoming changes with the Emergency Solution Grants (ESG). Grantee met with subrecipients regarding expenditure rates, invoice procedures, documentation concerns, etc. Grantee is working with subrecipients to meet the expenditure requirements. Subrecipients were provided a copy of Richland County's HPRP Policy and Procedure manual. A brochure on HPRP was also developed to provide additional information to consumers regarding eligible activities provided thru the County. Some of the lessons learned would be ensuring the Executive Directors of the non-profit or subrecipients understand HPRP procedures and assisting them in understanding what is required to process reimbursement requests. Grantee is continuing to work with them in this area.
