Conservation Committee: Gary Atkinson, Chair:

The committee needs to meet to develop criteria for the next round of community grants. We want to discuss a joint venture with the Planning Department to promote green development using the Green Code criteria. The Stormwater Roundtable arrived at a consensus on all twenty-two (22) of the Guiding Principals.

<u>Historic Committee</u>: Frank Houston, Chair

The Committee met last week and reviewed the upcoming grant cycle; January 8th suggested as deadline for applications so applications can be evaluated for recommendation to our January Commission meeting. The following changes in criteria and/or ranking were agreed upon:

- Priority will be given to new applicants through the matrix.
- Any grantee that has received 3 grants for the same project will be notified that, should they decide to apply again, their application will be placed in the "lowest priority"

category, and only considered after all new applications have been assessed and recommended for funding.

- Timely expenditure of prior grant funds will be considered in ranking applications.
- Promotional materials for the development of a "case for support" for capital campaigns of major historical projects will be eligible for funding.
- Applications will include questions on prior RCCC funding.

The RCCC website needs updating new photos and listing of grantees.
