

Ms. Barron stated, in the case of an electrical outage, what is the backup plan for the new electric locking mechanisms?

Mr. Leonardo Brown, County Administrator, responded there is backup power. We are not dependent on grid power that comes through the normal electrical process. In addition, the locks still have "old school" key turns; therefore, we will still have access to get detainees in and out of the cells.

Mr. Brown noted there are 191 detainees with violent charges that have been housed at the Detention Center for more than 366 days. He indicated the detainees who have been there for a number of years show a propensity to tear things up and damage the new stuff being put into the Detention Center. It is important that we continue to work with our internal partners to help us focus on problem individuals.

Ms. English inquired as to the plan for the upkeep of the renovations.

Mr. Brown replied that the County had begun to put aside funding for all capital projects we completed to ensure we could maintain them. While we have backups, the idea is not to make repairs due to individuals tearing up the facility.

Ms. English requested an update on transitioning the juvenile detainees to the Department of Juvenile Justice.

Mr. Crayman Harvey, Detention Center Director, noted they have conversed multiple times with DJJ leadership to establish a smooth transition plan. Effective August 1st, the Detention Center will cease receiving new juvenile detainees. On November 1st, the Detention Center will transition the existing juvenile detainees to DJJ.

Mr. Weaver inquired if the 191 detainees held at the Detention Center for over 366 days are all being held on Richland County charges.

Mr. Harvery responded that all detainees are being held on Richland County charges.

b. New Detention Facility:

Mr. Brown indicated that the current facility is nearing its capacity. In addition, he noted we cannot renovate ourselves out of what is not a great operational structure for the organization. He pointed out we have more staff than was anticipated when the facility was constructed, so we do not have general space for the staff. There are resources that need to be put into the facility to keep up with technology and ensure we are a better operational provider.




