EDC Meeting Minutes 2020 Hampton Street June 17, 2025 5:00 p.m.

CALL TO ORDER: Mr. Livingston called the meeting to order at 5:01 P.M.

APPROVAL OF MINUTES (6-3-25): Mr. Livingston called for a motion to approve the minutes from 6-6-25, So moved by Ms. Newton and seconded by Mr. Pugh In favor: Livingston, Newton and Pugh. Upon unanimous vote, the motion carried.

ADOPTION OF AGENDA: Mr. Livingston called for a motion for the adoption of the agenda, so moved by Mr. Pugh. Seconded by Ms. Newton. In favor: Pugh, Newton and Livingston. Upon unanimous vote, the motion carried.

Items for Action/Discussion:

A. Project Approval Process

Jeff Ruble gave a synopsis of the history of Economic Development in Richland County, including iteration of Alliances and the current Economic Development Office. Jeff outlined the way the Economic Development Office receives, vets and responds to projects. Finally, Jeff detailed how a project currently moves through the economic development process and the proposed revisions to the economic development project process.

Patrick Wright asked, a process question around incentives. "What is the benefit in adding the additional step?" Jeff stated, "it brings the Partnership into the decision making process, while allowing for additional expertise in the decision making process.

Ms. Newton asked, "What if any, communication process is there going to be between the EDC/County and the Partnership? and, "are there going to be cases where things going to the Partnership may not be brought before the Council?" Kate Bugby stated, that a report will be generated and presented to the EDC regardless of whether the Partnership accepts or declines a project. The report will be presented at subsequent EDC meeting.

Mr. Pugh calls for a motion to forward the proposed process to full Council for consideration. Ms.
