#### **CALL TO ORDER**

Mr. Jackson called the meeting to order at approximately 3:39 PM

#### **ELECTION OF CHAIR**

Mr. Pearce moved, seconded by Mr. Malinowski, to appoint Mr. Jackson as Chair. The vote in favor was unanimous.

#### **BUDGET AMENDMENT - \$4.5 MILLION FOR PHASE II**

Mr. Pearce inquired about the repairs due to the flood event.

Mr. Fosnight stated staff has being working with FEMA and Tetra Tech to secure funding for the repairs. The majority of the damage is not on the County's property. Mr. Fosnight further stated that he has been working with Ms. Ford, the property owner, to take care of the issues with the emergency spillway and the repairs on her property.

The total damages were approximately \$300,000. The County's portion is approximately \$47,000.

Mr. Jackson stated the \$4.5 Million budget amendment is for Phase II, which will include the amphitheater, the community building, the kids' playground, and strength the sheds in order to display the artifacts.

Mr. Malinowski requested a copy of the original Phase II proposal. He stated he did not recall the proposal calling for an amphitheater and a community building. He also did not recall \$1 million for the restroom facilities.

Mr. Jackson stated \$1 million was approved to construct restroom facilities on each side, the infrastructure and sidewalks leading to the facilities.

Mr. Fornight stated the approval was up to \$1 million. Presently there is not a way to get to the west side of the lake to construct restrooms; therefore, the only restrooms being constructed are on the east side of the lake.

Mr. Fornight stated the cost estimate for the restroom is \$500,000.

Mr. Pearce inquired who provides water and sewer service to the house on the property.

Mr. Fosnight stated the house is serviced by the City of Columbia for water and sewer.

Mr. Jackson stated there is a well on the property that supplies the irrigation.

Mr. Pearce inquired if the project was bid out or did Chao & Associates give us a price.

Mr. Fosnight stated it was done design build through Chao & Associates.

Mr. Malinowski expressed concern with putting shelters and restroom facilities on the other side of the lake.

Mr. Jackson suggested having a representative from Chao & Associates to attend the next meeting to explain the design of the restroom facilities.

Mr. Malinowski inquired about the distance from the existing infrastructure to where the facility is to be constructed.

Mr. Fornight stated it is approximately  $80\ \text{yards}$  from the street to the where the facility is to be constructed.

Mr. Pearce inquired if the project can be bid out.

Mr. Pearce stated in light of the public's attitude right now, if this project was in his district he would not be putting this on the table.

Mr. Malinowski moved, seconded by Mr. Pearce, to defer this until the next committee meeting. The vote in favor was unanimous.
