UPDATE—STATUS OF 2014 DIRT ROAD PAVING CONTRACTS

- ❖ Mr. Perry stated that the contractor is working on the punch list items for Summer Wind and Wilson Farm
- ❖ Pearce, Lavender, Allen, Eastover and Larkin the contractor is working to complete dressing and seeding the ditches.
- ❖ Kirk Road – there are concerns with the subgrade
- ❖ Lane has been working on Peafowl Drive, Ethels Avenue, Harold Street, India Street and Pilgrim Road
- ❖ William Duffie – piping has been laid
- ❖ Eagle Construction – Package C will be mobilizing on July 28th
- ❖ The Pre-Conference for Package D has been set with Lane

UPDATE—DIRT ROAD PAVING LIST PER AMENDED PAVING ORDINANCE

- ❖ Mr. Perry stated that the ordinance will be on the July 29th Special Called agenda for 3rd Reading
- ❖ The paving list will be corrected every year in November to reflect how the bids come in the previous year
- ❖ Split district roads need to be reviewed

PACKAGE B CHANGE ORDER RECOMMENDATION FOR WILLIAM DUFFIE ROAD

- ❖ Private waterline under the existing road is leaking up into the road, and without relocation of the waterline it would severely shorten the longevity of the planned pavement structure.
- ❖ The plans are to put the waterline along the ditch
- ❖ Mr. Washington moved, seconded by Ms. Dixon, to hold in committee for additional information. The vote in favor was unanimous.
- ❖ Additional information requested: (1) Who will have ownership; (2) Who will be responsible; (3) Does the private resident know who to contact

COMMITTEE DECISION ON INTERVIEWING SHORT LIST FIRMS FOR DIRT ROAD PAVING PROGRAM CONTRACT

- ❖ Mr. Perry stated that Council may conduct interviews of the short-listed teams
- ❖ If Council chooses not to conduct interviews the short-listed firms could be placed on the September 16th agenda
- ❖ If Council chooses to interview the earliest that the firms could be interviewed is September 19th and place on the October 7th agenda for action

Mr. Washington moved, seconded by Ms. Dixon, to present the short-list to Council at the September 16th Council meeting. The vote in favor was unanimous.
