Road Extension projects needs to get underway to open up the property for the Economic Development project.

In addition, Resurfacing Package H was awarded to Lane Construction but the contract has not been executed due to the DOR funding issue.

The Bluff Road Phase I Widening Project and Shop Road Phase I Extension Project are going to be advertised within the next 30-60 days. The intent is to award the contracts in September/October. If there is an ongoing issue with the funding the County could no award due to the lack of funding.

<u>Landscaping on Widening Projects</u> – Mr. Perry stated there have been meeting on the Atlas Road, Shop Road, Bluff Road and Clemson Road Widening. The community continues to express the landscaping on the widening projects are important to them. The issue from staff's perspective is there being is no funding in the penny for long-term maintenance.

Mr. Perry suggested handling the issue on a case by case basis similar to the way the undergrounding of utilities has been handled.
