Ms. McBride explained that SCARE and the Association of Counties was requesting the Richland County Board to take a position on whether it would agree or disagree to conduct the Republican PPP based on who funded the PPP.

Ms. Herbert requested an Executive Session for the sole purpose of obtaining legal advice. Seconded, and approved 4-0. Ms. Herbert moved to come out of Executive Session. Seconded, and approved 4-0. No action or votes were taken while in Executive Session.

Ms. Adams moved to recommend the Board agree for the County to conduct the Republican PPP provided necessary funds were provided by the State Republican Party to pay above what the State Election Commission does not cover. Seconded, and approved 4-0.
