CALL TO ORDER

APPROVAL OF MINUTES

May 18, 2015 – The minutes were approved unanimously.

SLBE PROGRAM UPDATE

Ms. Hutto stated:

- * 13 applications have been processed since July 1st
- * Of the 13 applications: 1 applicant was determined eligible for SLBE status, 1 voluntarily withdrew and the remaining 11 are still under review
- OSBO coordinated with the Procurement Department to finalize requirements for SLBE participation
- Resumed training for B2G Software system
- * The following items were taken up at the July 15th OSBO Ad Hoc Committee Meeting: Quick Pay Program, Mentor Protégé Program Development, Sheltered Market Program and partnering with McCartha-Cobb & Associates for Bonding Program
- McCartha-Cobb & Associates were approved by Council for the Bonding Program

THE COMET UPDATE

Dr. Schneider stated since the last meeting:

- * Lower Richland bus service will end at 7:30 p.m.

- * US Senate Transportation & Transit Bill would assist the COMET

JUNE 2015 PROGRESS REPORT: QUESTIONS AND ANSWERS

- Shop Road Extension Phase I SCDOT issued Right-of-Way acquisition authorization on June 25
- * Construction Authorization and Permit to Construct are the next steps
- Design-Build Intersections Project CR Jackson Construction Contract approved by Council at July 21st meeting
- * The Intersections included in the Design-Build Intersections Project are: Broad River Rd. and Rushmore Rd.; Clemson Rd. and Rhame Rd./North Springs Rd.; Farrow Rd. and Pisgah Church Rd; Kennerly Rd. and Coogler Rd./Steeple Ridge Rd.; North Springs Rd. and Risdon Way; and Summit Pkwy. And Summit Ridge Dr.
- * Clemson Rd. and Sparkleberry Ln. Intersection is a separate project
- ★ 3-4 Sidewalk/Bikeway Contracts will be put out for bid this fall
- Lincoln Tunnel is scheduled to be advertised in the near future
- * Three Rivers Greenway slated to go to construction in the spring

RESPONSE FROM COUNCIL CHAIR TO TPAC REQUEST

Mr. Mizell's understanding of the response was Council is open to reconsidering projects based on current needs, but the TPAC has no process or capacity to develop recommendations.

The best course may be to have those with transportation needs to communicate directly with Council.

Mr. Mizell stated the steps need to be formalized to bring transportation needs to Administration and Council's attention.

Mr. Faber stated he does not feel like the TPAC Committee has any role in putting forth any issues to the Council and the role of the committee need to be revisited.

Ms. Kososki stated the request forwarded to Chairman Rush on behalf of the City of Forest Acres is looking for implementation of the study that was untaken on behalf of the City by Boudreaux Architects.

COUNCIL ACTION UPDATE

- a. <u>Hardscrabble Road Widening Project –Supplemental Agreement</u> The Penny funding is making the widening possible because the SCDOT did not have the federal guide shares to take the project to construction. It is a \$7.2 million widening project from Farrow Rd. to Kelly Mill.
- **b.** <u>Vista Greenway Phase 2 (Lincoln Tunnel) Project Agreement Council approved agreement; project ready to be advertised; \$893,000 in penny funds; \$98,500 in federal grant funding from SC Parks, Recs and Tourism; and will take approximately a year to construct.</u>
- **c.** <u>Pavement Management Study Overview and Recommendation</u> Council approved the pavement management study
- d. <u>Bikeways and Sidewalks Public Involvement Meetings: Summary and Recommendation</u> Public meetings were held in June; received large amount of comments regarding bikeways from King's Grant
- e. <u>County Transportation Improvement Program (CTIP) Review and Revision</u> Will be brought back to TPAC in September/October
- f. CECS Service Agreement Design of Pineview Rd. widening
- g. Mead & Hunt Service Agreement Design sidewalks

Mr. Perry stated staff had a productive meeting with the State Infrastructure Bank Midlands representative. The recommendation was to split and submit two separate applications.

1. SLBE Certification Application Process

- Fifteen (15) applications were processed September 11 September 25, 2015
- One (1) new application was submitted
- Six (6) applicants have not submitted the required documentation to proceed with the certification process
- One (1) application was returned due to inactivity
- One (1) applicant has an upcoming site visit scheduled
- Two (2) applicants are under review for eligibility
- Four (4) firms have been approved for SLBE certification
- Four (4) firms have started applications but have not yet fully submitted all required documentation into B2GNow

2. Administrative Affairs

- The OSBO Ad Hoc Committee Meeting was held on September 14. In addition to agenda items, feedback on the Riverbanks
 Zoo/Rogers project was given by CBC, LLC; Procurement will conduct education sessions for internal departments to check the SLBE
 Directory for use of SLBE contractors on non-penny funded projects; and local preference limitations (percent versus points) were
 discussed. Committee members requested from CBC, LLC an assessment of needs and benchmarks for OSBO office.
- OSBO staff members attended job related workshops regarding Title VI training sponsored by SCDOT and procurement training held by South Carolina Fiscal Accountability Authority.
- On September 24 staff attended a "South Carolina Lender Matchmaker: Access to Capital" symposium sponsored by the City of
 Columbia. The symposium's purpose was: "Lender Matchmaker is a speed-networking event between lending organizations and
 small business owners. This is a unique opportunity designed to help small businesses assess their lending options in the most
 efficient way. This year, the event will consist of 2 Matchmaking sessions, allowing for one-on-one (15 minute) meetings with up to
 19 lending organizations." OSBO will now have information available as a resource tool to refer assist small businesses to Lender
 Matchmaker.

SECTION 1: JURISDICTION AND AUTHORITIES

- A. The Office of Small Business Opportunity (OSBO) through the Procurement Department is authorized by the Richland County Council to conduct compliance reviews to ensure compliance of with Richland County Ordinance No. 049-13HR, Division 7, "Small Local Business Enterprise Procurement Requirements".
- B. The Riverbanks Zoo and Garden Pedestrian Bridge Project is funded with Richland County Penny Sales Tax and is therefore subject to the Small Local Business Enterprise procurement requirements per Richland County Ordinance No. 049-13HR.

SECTION 2: PURPOSE AND OBJECTIVES

Purpose

- A. The purpose of the SLBE compliance review is to determine whether the apparent successful bidder is in compliance with Richland County Ordinance No. 049-13HR and the SLBE Program "Good Faith Effort" requirements.
- B. A Good Faith Effort requires prime contractor and/or bidders to demonstrate that every effort has been made to provide subcontracting opportunities to Richland County certified SLBEs. The prime contractor/bidder is required to meet an established SLBE goal or make "good faith effort" to satisfy the SLBE goal by committing to engage the services of certified SLBEs for potential subcontracting opportunities when the contract is solicited for bid. Should the prime contractor/bidder not meet the SLBE goal; the efforts made to attain the goal must be documented.
- C. A review of the proposed SLBE participation and the commitment of the prime contractor bid documents and support documents are performed prior to making recommendation of the award of the contract. In addition, periodic discretionary reviews of prime contractors' inclusion of SLBEs are conducted to determine whether the prime contractor is honoring the commitment in accordance with the Richland County Ordinance No. 049-13HR.

Objectives

- A. The objectives of the SLBE compliance review, as specified in Ordinance No. 049-13HR and the SLBE Program are as follows:
 - Ensure nondiscrimination in the award and the administration of Richland County funded contracts;
 - Create a level playing field that allow SLBEs to compete fairly for Richland County funded contracts;
 - Ensure that all SLBEs that meet Richland County eligibility standards are permitted to participate on Richland County funded contracts;
 - 4) Eliminate barriers that hinder the participation of SLBEs in Richland County funded contracts;
 - Help firms to develop the skills that are necessary to compete successfully on projects and programs outside of the SLBE program;
 - 6) Determine whether the prime contractor/apparent successful bidder is honoring the commitment represented by its certification to OSBO as a part of RC Ordinance No. 049-13HR.

SECTION 3: REVIEW OF THE CONTRACTOR'S COMMITMENTS

A review of Rodgers Builders Inc. (Rodgers Builders or Prime Contractor) for the Riverbanks Zoo Pedestrian Bridge Project (the Project), planned SLBE utilization was conducted to determine compliance with Ordinance No. 049-13HR and Richland County SLBE Program requirements.

Background Information

- A. One June 3, 2015, CBC completed calculations and proposed a project specific SLBE goal of 21%, based upon the Engineer's Estimate.
- B. An Outreach Meeting for the Riverbanks Zoo Project was held on June 3, 2015 at the OSBO. The meeting opened with the introductions of attendees who were later informed of Richland County's SLBE Program. A brief discussion of the project was presented; SLBEs were informed of what to expect and were encouraged to

market their services to Rodgers Builders. Attendees were informed that the project SLBE goal was 21%.

Terry Horomanski, VP of Rodgers Builders provided details of the project. James Clayton, Director of Diversity & Community Development outlined the requirements for prequalification documents and provided instructions on how one would access construction documents/plans via their online plan room; and indicated that the due date for receipt of bids was June 10, 2015.

- C. SLBE's demonstrated interest in participating on the project by asking numerous questions regarding the scope of work; inquired about forming teams with other attendees in order to pursue subcontracting opportunities; indicated that SLBEs were capable of performing services for all subcontracting opportunities; and requested representatives of Rodgers Builders to negotiate with them during the meeting. Concerns about the due date identified for submittal of bids were also expressed.
- D. Thursday, June 04, 2015 at 5:35 pm, Rodgers Builders sent an e-mail to SLBEs informing that the plans for the Riverbanks Zoo Project were posted to their website. The due date for receipt of bids was June 10, 2015 (See Attachment 1).

E. Subsequent to a review of Rodgers Builders pre-qualification requirements including the short period of 4-days that SLBE were given to examine contract documents, develop a bid, secure bonds, insurance and pre-qualification documents; a request for an extension the time for bid was submitted on June 8, 2015. Since no response was received, a letter request was submitted to Richland County (See Attachment 2, Ltr. dated 7-13-15) requesting a minimum of fourteen (14) days as required by South Procurement Law.

The following is a list of the required pre-qualification documents:

- a. Safety and Insurance Documentation:
- 1. Current Safety and Substance Abuse Policy
- 2. OSHA 300 and 300a logs from the past three years
- Certificate of Insurance Requirements are \$1M general liability (per project limits) and auto; \$3M Excess, State Statutory Limits for Worker's Compensation
- b. Financial and Bonding information:
- 1. Financial Statements including most recent audited Balance Sheet and Income Statement
- 2. A signed letter from your bonding agent stipulating current amount of bonding capacity per project, aggregate limit, bond rate and identifying the surety including A.M. Best Rating.
- 3. Completed IRS W-9 Form, Request for Taxpayer Identification and Certification
- c. Licensing and Certifications:
- 1. Minority Certification Letter from Governing Authority
- Applicable Licenses: General Contractor's license required for work over \$30,000.00. Licenses for work associated with architectural, electrical, mechanical and plumbing.
- 3. North Carolina Business License or reciprocal License

In addition, it was recommended that Rodgers Builders demonstrate a greater effort to involve SLBEs in the project by examining the scope of work to identify segments of work that can be subcontracted; and enhance efforts to involve SLBEs to include identifying firms listed in OSBO SLBE directory.

- F. July 24, 2013, Rodgers Builders agreed to extend the bid period (See Attachment 3). Notification was submitted to SLBE on July 27, 2015 identify the bid date was extended by 14 days. The notification included the date of August 10, 2015 as the date bids were due (See Attachment 4).
- G. SLBE were notified of the extension of the bid period on August 7, 2015, and were advised the request to waive the pre-qualification requirements had not been successful (See Attachment 5). Calls were received from approximately 90% of the SLBEs that attended the Outreach meeting to express disappointment in the time allowed for the submittal of pre-qualifications documents.
 - Calls were also received from the Greenway Group, the SLBE lighting distributor and installer whose bid information and data were disclosed to a competing firm. (See Attachments 6a & 6a)
- H. On August 11, 2015, Rodgers Builders agreed decrease for the OSHA logs from 3 years to 2 years, and the requirement for an audited financial statement was changed to a standard financial statement. However, all other pre-qualification documents were still required (See Attachment 7).

SECTION 4: DETERMINATION OF RESPONSIVENESS TO SLBE REQUIREMENTS

Rodgers Builders' SLBE commitment (Attachment 8) was examined to determine the accuracy in calculating proposed SLBE percentages; if work to be performed was a Commercially Useful Function (CUF); and the amount of the proposed SLBE participation that did not qualify and cannot be counted towards the SLBE goal.

Responsiveness and Compliance:

- 1) SLBE Program Submittal Requirements (Attachment 9)
 - a. A list of the names of SLBEs that Rodgers Builders intend to award contracts to, for participation on the Riverbanks Zoo (Pedestrian Bridge) Project.
 - b. A list of the trade areas/services that will provided/perform by SLBEs;
 - c. The amount of work/services that has been committed for each SLBE;
 - d. The total SLBE goal percentage committed by Rodgers Builders that also represents the SLBE participation on the project.

- e. The efforts made by Rodgers Builders towards meeting the SLBE goal including copies of correspondence and fax logs; and copies of advertisements/solicitations, etc.
- f. The names of all non-SLBEs (contractors and suppliers), and the percentage of work Rodgers Builders has committed for the participation of non-SLBE on the project.

An assessment of the SLBE Program submittal requirements listed in Section 4, Item 1, above, was performed. The results of the assessment are included below:

- a. Orion Construction and Corley Construction are listed as SLBE subcontractors in Rodgers Builders Estimate Summary; however the services to be performed by Orion and Corley are not clearly identified.
- b. The services to be provided by the SLBE subcontractors must be clearly identified by the contractor, in order for such services to be validated as a Commercial Useful Function, prior to being counted towards to the SLBE goal.
- c. The total amount allocated for several SLBE and non-SLBE sub-contractors have been combined and is listed on the line items for various trades/ services. As a result, it is difficult to ascertain the total amount that has been committed to the SLBE for each trade. The total amount for each SLBE must be itemized and verified prior to being counted towards the SLBE goal.
- d. A total amount of \$326,000.00 for services to be performed by SLBEs and 16.1% commitment to SLBE listed in Rodgers Builders estimate summary dated August 24, 2015 cannot be verified.
- e. Correspondence from Rodgers Builders dated August 24, 2015, (Attachment 8) describes efforts made to involve SLBE, but failed to include a listing of fax logs confirming communications to SBLEs; record of negations with SLBEs; a description of assistance to SLBE to support with bonding; identified no assistance to facilitate discussions between electrical manufactures and SLBE lighting distributor (See Attachment 10); and no documentation or records of follow-up communications/outreach requesting assistance from OSBO to encourage SLBEs to participate on the project.

f. We were also unable to verify the total amounts and percentages of work committed to non-SLBEs, since the amounts estimated for non-SLBEs and SLBEs are combined and shown in the subtotal amount for the respective line items.

SECTION 5 - SLBE GOAL COMMITMENTS AND SUMMARY

The SLBE goal commitment for Rodgers Builders was listed at 16.1 percent and the SLBE services were estimated to be \$326,000.00. We were unable to verify or confirm the SLBE goal since the respective line item amounts reflect the names of SLBEs and non-SLBEs.

SECTION 6 - DETERMINATION OF GOOD FAITH EFFORTS

The prime contractor, Rodgers Builders, Inc. failed to demonstrate a "Good Faith Effort" in accordance with the requirements of Richland County Ordinance No. 049-13HR and the SLBE Program "Good Faith Effort" requirements.

Pertinent factors that led to this conclusion include the following:

- 1) Several quotes received from qualified SLBEs that were not considered as part of the commitment and were not included in the SLBE goal.
- 2) Several SLBEs were rejected as being unqualified and no justification or the basis on which such a decision was made was not provided to the OSBO.
- 3) There was no indication of any type(s) of assistance that were given or provided for SLBEs wanting to provide services on the project.
- 4) To be count as SLBE participation toward the SLBE goal, each SLBE must be certified in a trade/service area listed in the NAICS code. A description of the applicable trade/service area was required in order to validate the specific work/ services to be performed by the SLBEs.
- 5) Several opportunities for which qualified SLBEs expressed interest and willingness to participate and provide services on the project, were reserves or committed to non-SLBEs.

6) Rodgers Builders apparent unwillingness to waive the unnecessary pre-qualifications requirements; and the delay caused by Rodgers not wanting to extend the period for the receipt of bids.

Dear Ms. Patrick/Mr. Perry:

The following documents our concerns and findings pursuant to non-compliance with the intent of Richland County (RC) Small Local Business Enterprise (SLBE) Program including the inclusion of RC-SLBEs for the Pedestrian Bridge at Riverbanks Zoo Project. This letter also contains suggestions from Comprehensive Business Consultants, LLC (CBC) with reference to widely acceptable efforts for non-federal and federally funded projects.

Specific concerns with Rodgers Builders efforts:

- The time allowed for SLBEs to develop and submit bids; and complete Rodgers Builders Trade Contractor Prequalification Application appeared to be inadequate;
- Rodgers Builders disclosure that the cost proposal from the Green Way Group, LLC, a SLBE lighting distributor was given to a non-SLBE lighting subcontractor, a potential competitor of the SLBE lighting distributor;
- That the determination of the electrical non-SLBE subcontractor, that the alternate light fixtures proposed by the SLBE lighting distributor was not equal to light fixtures identified in contract specifications was deemed to be correct;
- 4) Rodgers Builders inference that Orion Construction, SLBE subcontractor, did not submit documentation as required by the Rodgers Builders' Contractor Prequalification Application. It is our understanding that the documentation was submitted, and additional documents were requested;
- 5) That Orion Construction submitted a bid to perform several phases of work. However, Rodgers Builders requested the SLBE to select a different phase of work.

ITEM NO. 1 - Time Allowed to Prepare a Competitive Bid

On June 3, 2015 during the Outreach Meeting, Rodgers Builders requested attendees to submit bids for the Riverbanks Zoo and Garden Project by June 10, 2015. Rodgers indicated that the contract specifications (bid documents) would be posted on their website. Attendees were further advised that each bidder must complete and submit the Trade Contractor Prequalification Application and required pre-qualification documents (see Att. A) by June 10th.

RESPONSE:

Bid documents were posted to Rodgers Builders' website on Thursday, June 4, 2015 at 5:35 pm (see Att. B). Bidders were extended a total time of approximately four (4) days to develop a bid; complete the seven (7) page Trade Contractor Prequalification Application; and assemble and submit required documents. The allotted time to bid the project appeared to be inadequate for competitive bidding.

ITEM NO. 2 – Unauthorized Disclosure of SLBE's Bid

Rodgers Builders disclosed the cost proposal from The Green Way Group, SLBE lighting distributor, to Carolina Power a non-SLBE electrical subcontractor (see Att. C). Carolina Power informed they would evaluate The Green Way Group's proposal, if their cost was acceptable they would include Green Way Group's pricing in with their pricing to Rodgers. Carolina Power also determined the quote from The Green Way was in complete.

RESPONSE:

Carolina Power is not known to be a part of Rodgers Builders' team, or under contract to provide electrical contracting services on the project. That (without permission) the cost proposal from The Green Way Group was given to another contractor that could potentially be a competitor for lighting fixtures was unfortunate and irresponsible.

Rodgers Builders accepted Carolina Power's assessment that the alternate light fixtures suggested by the Green Way Group were not equal to the fixtures in the specifications; and that their bid was incomplete.

Competitive bidding requires each sub-contractor/supplier bid to be kept confidential.

ITEM NO. 3 - SLBE LIMITED TO SELECTED PHASES OF WORK

Rodgers Builders inferred that Orion Construction, a SLBE did not submit prequalification documents; and further that Orion Construction was most comfortable with performing the masonry scope of work or possible the flatwork portion of the concrete.

RESPONSE:

Orion Construction completed the prequalification application and submitted the required documents. However, Rodgers Builders requested <u>additional</u> insurance documentation on a later date. The firm bid the concrete and masonry scope of work.

Rodgers Builders asked Orion Construction "if they were only awarded one phase of the work would that deter them"; and further requested Orion to identify the phase of work they felt most comfortable performing.

Orion Construction advised Rodgers Builders that they were capable of performing the work they bid on. However, if had to choose one phase of the work, at this time, they would prefer the masonry work.

DETERMINATION OF GOOD FAITH EFFORTS:

The good faith efforts by the prime contractor, does not meet the RC SLBE Program requirements. Evaluation of Rodgers Builders good faith efforts was based upon review of documentation included Rodgers Builders' letter dated July 1, 2015 and their e-mail dated June 4, 2015 notifying firms of the solicitations; e-mails from SLBEs; e-mails from a non-SLBE contractor; and communications with SLBEs.

Records indicate solicitation for the project was extended; however, the bidders require a <u>reasonable period</u> in which to prepare their bids. According to Procurement Law, the date for receipt of bids <u>must be not less than seven (7) days</u> after the solicitation is made available. This time mirrors the time allowed for procurements, including the State of South Carolina Code of Regulation.

It is common practice for invitation for bids to provide 14 days and up to 30 days for response. Historically, adequate allotted bid times reduce risks in calculation errors; and result in increased number of bids received.

Rodgers Builders indicated that SLBEs were not available; and only 2 bids were received. Twelve (12) of the sixteen (16) SLBEs that attended the Outreach Meeting informed OSBO that the reason for not bidding the project was that the time allowed to respond to the bid was insufficient.

It is determined therefore, that efforts made by Rodgers Builders, Inc. to involve SLBEs in the Pedestrian Bridge at Riverbanks Zoo Project do not demonstrate acceptable good faith efforts.

Good faith efforts should reflect, but is not be limited to, the following:

- Reasonable time to develop a bid;
- 2) List of rejected bids and the reasons for rejections;
- 3) Records of negotiation with SLBEs;
- 4) Offers of assistance to overcome barriers and follow up calls;
- 5) Advertisements in news papers and social media sites;
- 6) Professional/technical assistance offered to SLBEs;
- 7) Solicit additional assistance from RC-OSBO.

RECOMMENDATION:

A greater effort should be made by the contractor to involve SLBEs in the project. Extend the bidding time and examine the scope of work to identify segments of work that can be subcontracted. Enhance efforts to involve SLBEs to include identifying firms listed in OSBO SLBE directory; contact and meet to discuss requirements to perform opportunities; and request additional assistance from OSBO.
